

## **46th Nationale-Nederlanden Warsaw Marathon Regulations**

### **1. Organizer**

1. The organizer of the 46th Nationale-Nederlanden Warsaw Marathon is the Warsaw Marathon Foundation; ul. Brylantowa 15, 05-077 Warszawa, NIP 9521913280, REGON 015438288 registered in the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw under the number: 0000152754.

### **2. Date and place**

1. The races will take place on September 29, 2024, in Warsaw.
2. 46<sup>th</sup> Nationale-Nederlanden Warsaw Marathon will start at 9:00 AM, and the start line will be closed approximately 10 minutes after the starting signal whereas Nice To Fit You Warsaw 10K will start at 9:30 AM, and the start line will be closed approximately 5 minutes after the starting signal.
3. The length of the route is 42.195 km. The route has the approval of the Polish Athletics Association (PZLA) and World Athletics.
4. The exact route of the race will be announced on the website <https://maratonwarszawski.com/>. The organizer reserves the right to change the route, informing participants by posting the new route on the website <https://maratonwarszawski.com/>. Such a change does not result in any additional claims or obligations.
5. The route will be marked with vertical and horizontal signs every 1 kilometer.
6. Participants will line up at the start in designated zones, according to the colors indicated on their race numbers. Allocation to a specific zone is based on the participant's declared time, provided in the registration form. Editing the declared time is possible until August 31, 2024. Participants who pay the entry fee after August 31, 2024, are not guaranteed placement in the time zone based on the declared time.
7. The organizer reserves the right to change the start time, informing participants by posting relevant information on the website <https://maratonwarszawski.com/>.

### 3. Time limit

1. Participants are subject to a time limit of 6 hours and 30 minutes, calculated from the starting signal.
2. Additional time limits are set at 3 hours and 15 minutes at the halfway point and 4 hours and 45 minutes at the 30 km mark.
3. Participants who do not finish the race within the specified time limit or do not cross the time measurement points within the designated time limit are obligated to interrupt the race and leave the course or reach the finish by bus with the sign 'END OF RACE.'
4. Participants remaining on the route after the specified time limit do so at their own risk and responsibility, in accordance with traffic regulations and the Civil Code."

### 4. Participation

1. Only individuals who will turn 18 years old by September 29, 2024 (born before September 29, 2006), have the right to participate in the race.
2. All participants entering the race must undergo verification at the Race Office or choose the option of sending the Starting Package (the rules of which are specified in Chapter VI of these regulations). Verification at the Race Office can be done:
  1. personally – based on a photo ID
  2. by an authorized person – based on a signed participant card (available for download from the website approximately two weeks before the race) and a photocopy of the participant's ID."

Note! On the day of the race, the Race Office will not be open.

3. At the Race Office, participants will receive race packages containing, among other items: a race number with a timing chip, safety pins, and a commemorative t-shirt (according to the selected package option). T-shirts at the Race Office will be

distributed based on the earlier declaration. T-shirt size should be selected in the registration form. Changing the t-shirt size is possible by editing the registration form, but no later than September 10, 2024. The availability of shirts in a given size is limited, and the organizer does not guarantee its availability at all times.

4. Unclaimed race packages at the Race Office will not be sent or distributed at a later date.
5. During the race, all participants must have their race numbers horizontally attached to the front of the shirt (or hoodie or jacket). The race number must be visible throughout the entire race; obscuring the number (entirely or partially, during any part of the race) or modifying it is prohibited under the penalty of disqualification. The timing chip is integrated with the race number. Tampering with the timing chip (bending, peeling, etc.) or placing the race number anywhere other than horizontally on the front of the chest may result in improper functioning of the timing chip and, consequently, the lack of the participant's result.
6. Starting with someone else's race number is not allowed and results in the disqualification of the registered person.
7. The organizer allows the participation of wheelchair athletes with direct drive. After completing the registration form expressing the desire to participate in a wheelchair, these athletes should send a scan of a document confirming their disability to [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com) – this is a condition for granting a 50% discount on the entry fee (package without a t-shirt). The organizer does not allow wheelchair athletes with indirect drive (e.g. hand-bike) and rim-push type.
8. Participants in the race must adhere to the rules of the Polish Athletics Association (PZLA), World Athletics, and these regulations.
9. In accordance with PZLA guidelines, participants representing Russia and Belarus are excluded from participating in the 46th Nationale-Nederlanden Warsaw Marathon. An exception is participants of Belarusian nationality permanently residing in Poland who send a scan of the DECLARATION to [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com). These athletes compete without representing any country.
10. The organizer provides medical assistance at the start, on the route, and at the finish during the race.

## 11. Registrations

1. Registrations are accepted through the registration form available on the websites: <https://maratonwarszawski.com/> & <https://rejestracja.maratonwarszawski.com/>.
2. The registration is considered complete if the following conditions are met: the registration form is filled out, and the payment of the entry fee is recorded.
3. To participate in the 46th Nationale-Nederlanden Warsaw Marathon, you can register by choosing one of two paths:
  1. traditional – by filling out the registration form available on the event's website and paying the standard entry fee
  2. charitable – by participating in the #IRunWell campaign, regulated by a separate set of rules."
4. Online registrations will close on September 28, 2024. Registration for the race will also be possible in person at the Race Office of the 46th Nationale-Nederlanden Warsaw Marathon, with the caveat that the total pool of race numbers for those registering after September 27, 2024, and available at the Race Office is limited to 200.
5. The organizer reserves the right to close registrations earlier in case the participant limits specified in point V.4 are reached."

## 6. The shipment of the race package

1. "Participants of the 46th Nationale-Nederlanden Warsaw Marathon have the option to use the race package delivery service.
2. The race package delivery involves sending a package containing the race materials (race number, timing chip, safety pins, and a commemorative t-shirt – according to the selected package option) via a courier company to the address provided by the participant, according to the terms specified in the regulations of the national courier and postal services company.
3. The race package delivery service is available only within the territory of Poland.
4. The race package delivery includes sending the race number with the timing chip, safety pins, and optionally a commemorative t-shirt (according to the selected package option). Gadgets from sponsors are not included in the race package delivery and are only distributed at the Race Office during personal pickup of the race package.

5. The race package delivery is an additional paid option. The fee for the Race Package Delivery is 9 EUR (gross) per participant.
6. Ordering and payment for the race package delivery option are possible until September 4, 2024.
7. The condition for the race package delivery is to have a race number (assigned after the entry fee is recorded) no later than September 4, 2024, and to send a clear scan or photo of the signed Starting Card to the email address [wysylka@maratonwarszawski.com](mailto:wysylka@maratonwarszawski.com). The deadline for sending the aforementioned documents is September 7, 2024. In case of non-delivery of the required documents, the race package can be collected at the Race Office under standard conditions, and the race package delivery fee is not refunded.
8. The deliveries will be made approximately two weeks before the race. In case of non-receipt of the package by September 23, 2024, the participant should report this to the Organizer at the address [wysylka@maratonwarszawski.com](mailto:wysylka@maratonwarszawski.com).
9. Participants using the delivery option are not required to verify at the Race Office.

## 7. Fees

1. Every participant in the 46th Nationale-Nederlanden Warsaw Marathon incurs the cost of the entry fee. An exception is made for participants in the #IRunWell campaign, whose procedure is described in a separate REGULATIONS document. The entry fee includes the race package (point IV.3 of the Regulations) as well as the support of the participant before, during, and after the race, the rental and/or purchase of infrastructure necessary for the organization of the race, and the maintenance of the online registration website for the Race and the Race website.
2. Basic entry fee rates for participants from abroad: The fee at the Race Office (September 27-28, 2024) is 120 euros.

5. The participant also has the option to order additional options and services, the prices of which are:

6. The pool of shirts is limited. If a participant selected a shirt in the registration form, did not pay the entry fee within 7 days of submitting the registration, and the availability of shirts is low, the Organizer reserves the right to remove the chosen (unpaid) shirt from the registration and will inform the participant via email.

7. Individuals who made the entry fee payment after September 17, 2024, and did not receive confirmation of the assigned race number must present proof of payment confirmation at the race office.

8. In case of an insufficient entry fee payment (e.g., due to exceeding the payment deadline specified in this regulation), the participant is obliged to pay the difference to the amount he was supposed to pay according to the deadline of his last payment.

10. "The Organiser grants a 25% discount on the basic entry fee (package without a T-shirt) for individuals born on 29.09.1959 or earlier at the time of payment of the entry fee. For participants in wheelchairs, the Organiser grants a 50% discount on the basic entry fee (package without a T-shirt) at the time of payment of the entry fee, provided that a scan of a document confirming disability is sent to [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com).

11. Proof of payment is the appearance of the participant's start number on the start list on the <https://maratonwarszawski.com/> website. If the start number does not appear after 7 days, the participant must contact the organiser by phone: (+48 22) 266 21 00 or by email: [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com).

12. The Organiser is not responsible for the loss of registration or transfer due to the fault of the post office or bank.

13. In accordance with Article 38(12) of the Consumer Rights Act, participants who are consumers within the meaning of Article 22(1) of the Civil Code (Polish law) do not have the right to withdraw from the contract. The fee once paid is non-refundable, non-transferable to another person or to another race in the future, or exchangeable for a voucher. The exception is when the participant selects and pays for the "Refund Option" during registration. The cost of the service is EUR 10 and is non-refundable.

14. In the event of choosing the option described in point VII.13, the participant acquires the right to resign from the race without giving any reason and receive a 100% refund of the paid entry fee, including the selected additional options, provided that the intention to resign from the race is reported by 26.09.2024 (in the case of picking up the starter pack at the Race Office) or by 07.09.2024 (in the case of using the option of sending the starter pack).

15. The resignation described in point VII.13 of the Regulations must be carried out by logging into the participant's account on the <https://rejestracja.maratonwarszawski.com/> website and selecting the "I resign from the race" button in the YOUR RACES tab.

16. A participant who resigns from the race will receive a 100% refund of the entry fee and additional services purchased (except for the Race Withdrawal Fee) within 21 days in the same payment method as the fee was paid. The refund described in point VII.16 does not apply to fees paid using a "promotional code".

17. People who want to receive an invoice for the paid entry fee should select the appropriate option in the registration form and enter the required data needed to issue the document. The invoice will be generated automatically after the payment is recorded and will be available for download from the participant's profile by the 15th day of the month following the month in which the payment was made.

18. In accordance with tax regulations, due to making the payment before the service is provided, a pro-forma invoice covering the full amount of the paid fee will be issued. Thus, the pro-forma invoice is also a final invoice.

19. By selecting the Invoice option, the Participant agrees to receive/share invoices without the recipient's signature, electronically. This consent does not exclude the Organiser's right to issue and send invoices in paper form.

20. To receive a Pro-Forma invoice, please send: invoice details, the number and list of participants (with registration numbers), along with information about the selected package option to [ksiegowosc@maratonwarszawski.com](mailto:ksiegowosc@maratonwarszawski.com). Pro-Forma invoices are issued for the start of at least two participants (it is not possible to receive a Pro-Forma for the start of a single person)."

### **1. Deposits, Catering**

4. Participants will receive a bag with a sticker in their race packet, allowing them to deposit their belongings at a designated area. The bag can only be collected upon presenting the race number. In the event of a participant losing their race number, the Organizer is exempt from responsibility for another person collecting the bag. Note! It is prohibited to deposit valuable items and documents.

5. Before the race, participants will have the opportunity to use changing rooms. After the race, participants will have access to changing rooms, massage services, and showers.

6. All race participants will receive: the opportunity to use refreshment stations along the race route and a regeneration package at the finish line (a drink and a meal)."

### **2. Refreshment points and checkpoints**

4. Refreshment points equipped with water will be located at intervals of approximately 2.5 kilometers starting from the 5th kilometer. Additionally, at every other point starting from the 10th kilometer, isotonic drinks and bananas will be available.

5. The organizer does not accept private refreshments from participants.

6. Near each refreshment point, portable toilets will be available.

7. Time measurement checkpoints will be located at the 5th, 10th, 15th, 20th, 25th, 30th, 35th, and 40th kilometers, as well as at the halfway point.

8. The staff at the checkpoints will record the race numbers of participants shortening the route. Participants shortening or changing the route will be disqualified.

### **3. Classifications and Results**



4. During the 46th Nationale-Nederlanden Warsaw Marathon, the following classifications will be conducted:
  1. Overall Classification
  2. Overall classifications for women / men
  3. Age Category Classifications:
    - K-20 / M-20 (Age Group 1995-2006)
    - K-30 / M-30 (Age Group 1985-1994)
    - K-40 / M-40 (Age Group 1975-1984)
    - K-50 / M-50 (Age Group 1965-1974)
    - K-60 / M-60 (Age Group 1955-1964)
    - K-70 / M-70 (Age Group 1945-1954)
    - K-80 / M-80 (Age Group 1944 & older)
  4. Team classification (The classification is governed by a separate set of rules – <https://maratonwarszawski.com/team-up-everyone-regulamin/>)
  5. Industry classifications (with gender division) – participants can choose a maximum of one classification in which they want to participate:
    - academic – students
    - academic – lecturers
    - bankers
    - journalists
    - traders and FMCG producers, as well as restaurateurs
    - education sector employees
    - lawyers
    - medical services
    - uniformed services
    - insurance professionals
    - public sector officials
    - Polish Blogger Championships in the marathon
  6. Classification of wheelchair athletes (these athletes are excluded from other classifications)
5. The basis for classification is electronic time measurement. There will be control mats on the race route that record the participant's presence at a given point. Failure to register the participant at a specific point may result in disqualification.
6. The general classification is based on actual times (net – counted from crossing the start line). An exception is the first

200 people crossing the finish line – they are classified based on official times (brutto – from the starter's shot), with the proviso that if among the first 200 people at the finish line there are not at least 8 men and 8 women, the number of 200 people will be increased to include them. All additional classifications (age, industry) are based on actual times (net – counted from crossing the start line).

7. In the final race results, each participant receives information about both gross and net times.
8. Unofficial race results will be posted on the website <https://maratonwarszawski.com/> immediately after the race.
9. Results of industry classifications will be available on the website <https://maratonwarszawski.com/> within 3 days after the race.
10. Written protests regarding the results will be accepted until October 1, 2024, at 6:00 PM, at the email address [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com). Protests will be reviewed within 96 hours, and the final and official results will be published no later than October 14, 2024.
11. The diploma (certificate) of completing the 46th Nationale-Nederlanden Warsaw Marathon for self-printing will be available for download through the website <https://maratonwarszawski.com/> at the latest 21 days after the event.
12. The organizer reserves the right to introduce additional classifications.

#### **4. Awards**

4. All participants who complete the 46th Nationale-Nederlanden Warsaw Marathon will receive commemorative medals at the finish line.
5. The winners of 1st to 3rd places in the general classification for women and men, as well as the winners of 1st to 3rd places in age classifications, will receive commemorative statuettes.
6. The organizer reserves the right to award additional cash and material prizes in categories and classifications of their choice.

#### **5. Personal Data Protection**

4. Participants' personal data will be processed in accordance with applicable regulations, especially with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal

data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

5. The data processing mentioned in point XII.1. also includes the publication of: first name, last name, year of birth, town name, and club name.

6. Detailed information regarding the processing of personal data is provided in Attachment 1 to this Regulation.

## 6. Final provisions

4. Participants can file any complaints within 7 days from receiving the race pack. Participants should check the completeness of the race pack upon receipt. A response to the complaint will be provided promptly, no later than 30 days from its submission.
5. It is prohibited to be on the 46th Nationale-Nederlanden Warsaw Marathon route without a valid race number. Individuals without a valid race number will be removed from the route by event staff. Specifically, moving on the race route using bicycles, rollerblades, skateboards, other mechanical devices, and pushing strollers without valid permission from the Organizer is prohibited. The use of Nordic walking poles and running with dogs is also prohibited on the route. Only Organizer's vehicles (bicycles, motorcycles, cars) with a valid pass issued by the Organizer are allowed on the route.
6. To obtain individual permission to participate with a stroller, participants must send a scan of the DECLARATION to [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com) and provide the original during race pack collection.
7. During the race, participants must follow the instructions given by safety personnel, security services, and other individuals designated by the Organizer. Non-compliance may result in disqualification.
8. The Organizer provides each participant with accident insurance for the duration of the race.
9. Each participant is required to sign a declaration of familiarity with the regulations. By signing the declaration, participants agree to receive first aid, perform other medical procedures, and transport the injured to a safe place by medical and paramedical personnel acting on behalf of the organizer.
10. Participants declare that they are fit to participate in the race, have no health reasons excluding them from participating, and

that they participate at their own risk. They acknowledge that participating in the race involves physical effort and carries the natural risk of accidents, bodily injuries, and physical injuries (including death), as well as damage and financial loss. Furthermore, other unpredictable risk factors may be associated with participating in the event. Signing the declaration of familiarity with the regulations means that the participant has considered and assessed the scope and nature of the risks associated with participating in the race, and they participate voluntarily and solely at their own risk. The decisions of doctors regarding the continuation of the race during the event are final and irreversible.

11. A doping control will be conducted after the race, and the participant designated by the Commission must undergo it without exception.
12. The general classification is based on electronic time measurement. Mats on the race route record the participant's presence at a given point. The absence of a reading of the participant's presence at a given point may result in disqualification.
13. The general classification is based on net times (measured from crossing the start line), except for the first 200 individuals crossing the finish line. They are classified based on official times (gross – from the starting signal), with the proviso that if there are fewer than 8 men and 8 women among the first 200 individuals at the finish line, the number of individuals will be increased to include them. All additional classifications (age, industry) are based on net times.
14. Unofficial race results will be posted on <https://maratonwarszawski.com/> immediately after the race. Results of industry classifications will be available on <https://maratonwarszawski.com/> within 3 days after the race.
15. Written protests regarding the results will be accepted until October 1, 2024, 6:00 PM, at the email address [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com). Protests will be reviewed within 96 hours, and final and official results will be published no later than October 14, 2024.
16. A diploma (certificate) of completing the 46th Nationale-Nederlanden Warsaw Marathon for self-printing will be ready for download through <https://maratonwarszawski.com/> no later than 21 days after

the event. The Organizer reserves the right to introduce additional classifications.

17. All participants who complete the 46th Nationale-Nederlanden Warsaw Marathon will receive commemorative medals at the finish line. Winners of 1st–3rd places in the general classification for men and women, as well as winners of 1st–3rd places in age classifications, will receive commemorative trophies. The Organizer reserves the right to award additional cash and in-kind prizes in selected categories and classifications.

### **What is the purpose and legal basis for processing your personal data?**

  - your participation in the races for which you register through the website <https://rejestracja.maratonwarszawski.com/> (preparation of the starting package, insurance, results processing, award distribution, etc.)
  - publishing publicly available start lists and results
  - providing payment services

- sending organizational information (email / SMS) about the races for which you register through the website <https://rejestracja.maratonwarszawski.com/>
  - handling registrations and correspondence directed to us by you
  - contacting you
  - facilitating contact with the charitable organization you support (in the case of charitable registration #IRunWell)
3. fulfilling legal obligations imposed on the "Warsaw Marathon" Foundation
- for tax and accounting purposes
4. for purposes arising from the legally justified interests of the "Warsaw Marathon" Foundation:
- direct marketing of products and services
  - handling registrations and correspondence directed to us
  - contacting you
  - preventing fraud and abuse
5. based on the consent you have provided:
- sending marketing information (email / SMS)

### **Do you have to provide personal data?**

Providing personal data is necessary both for your participation in the race and for managing your account on the <https://rejestracja.maratonwarszawski.com/> website.

Failure to provide personal data makes it impossible to conclude a contract and participate in the race.

### **How long will your personal data be processed?**

Your data will be processed during the use of the <https://rejestracja.maratonwarszawski.com/> website and participation in the races for which you sign up through the website.

After the end of this period, your data will still be stored for the purposes arising from legal regulations (especially tax and accounting) as well as for preventing fraud and abuse and pursuing any claims arising from the concluded contract.

Part of your data, especially those found in the race results, may also be processed beyond this period for statistical and archival purposes.

### **Who will be the recipient of personal data?**

Your personal data will be disclosed to employees, associates, and subcontractors of the Administrator to the extent necessary for the implementation of the aforementioned purposes of personal data processing.

Start lists and results, containing basic personal data, will be publicly available, including being published on the race website.

### **What rights do you have regarding the processing of your personal data?**

You have the right to request access to your personal data, their correction, deletion, and restriction of processing. Additionally, you have the right to object to their processing and to data portability.

Moreover, in relation to processing based on your consent, you have the right to withdraw it at any time.

### **To whom can you complain about the processing of your personal data?**

You can lodge a complaint with the supervisory authority: the President of the Office for Personal Data Protection; Stawki 2, 00-193 Warszawa.

### **Regulations of the #IRunWell Campaign within the 46th Nationale-Nederlanden Warsaw Marathon**

1. The participant, when registering for the race, is obliged to choose one of the possible registration paths:
  1. traditional – by completing the registration form available on the event's website and paying the prescribed entry fee
  2. charitable – by participating in the #IRunWell campaign, governed by these regulations"

2. "To participate in the #IRunWell campaign, you need to:"
  1. Choose the 'charity path' in the race registration form.
  2. Select a charitable goal for the collected funds. You can choose from 11 available charitable organizations: Rak'n'Roll – Fundacja „Rak'n'Roll – Wygraj Życie”, Amnesty International Association, Fundacja Dajemy Dzieciom Siłę, Fundacja Synapsis, Fundacja „Wcześniak Rodzice Rodzicom”, Fundacja Spartanie Dzieciom, Polska Akcja Humanitarna, Fundacja „Na Ratunek Dzieciom z Chorobą Nowotworową”, Fundacja DKMS, Fundacja Twarze Depresji, Fundacja Avalon.
  3. Complete the required information on the fundraising profile (a page visible to all website users through which support for a particular fundraiser is possible).
  4. Fill out the standard race registration form (declared time, additional classifications, etc.).
3. After completing the registration, the participant receives an email with a link to their individual fundraising page.
4. Participants who accumulate at least PLN 450.00 in their fundraising account by August 31, 2024, receive a race number for the 46th Nationale-Nederlanden Warsaw Marathon. The participant's registration fee is covered by the supported charity organization.
5. The race number obtained in this way, along with the charity starter pack for the 46th Warsaw Marathon, is non-refundable and cannot be transferred to another participant or another race.
6. Fundraising for individuals who have not reached the amount specified in point 4 ends on August 31, 2024, and the funds collected in this way are transferred according to point 8 of this regulation.
7. Fundraising for individuals who have reached the amount specified in point 4 of the regulation (or exceeded it) continues until October 4, 2024.
8. The collected funds, after deducting fees and commissions (related to online payments), are distributed:
  1. 90% of the collected amount goes to the account of the chosen charitable organization.
  2. 10% of the collected amount is allocated for the maintenance and development of the ##IRunWell campaign as well as the statutory goals of the “Warsaw Marathon” Foundation.

This division occurs independently of the amount collected and the achievement of the goal indicated in point 4.



9. The participant, when registering for the #IRunWell Campaign, agrees to transfer the funds collected by them to the account of the chosen charitable organization according to point 8 of the Regulations.
10. The participant can resign from further fundraising at any time and transfer their registration from the 'charitable path' to the 'traditional path' by selecting the appropriate option in their profile on the website <https://rejestracja.maratonwarszawski.com/>. Previously collected funds go to the designated organization according to point 8.
11. A participant who received a starting number as part of the #IRunWell campaign, as mentioned in point 4, can order a T-shirt in accordance with the regulations of the 46th Nationale-Nederlanden Warsaw Marathon, which must be paid for by September 7, 2024, at the latest.
12. Participants in the #IRunWell campaign are subject to the Regulations of the 46th Nationale-Nederlanden Warsaw Marathon.

As part of the initiative, Nationale-Nederlanden Life Insurance S.A. will provide additional funds to the organizations for which the participants of the 46th Nationale-Nederlanden Warsaw Marathon raise the most money. The top three fundraisers, as of September 28, 2024, at 12:00 PM, will be awarded based on the total amount raised.

The additional funds provided by the sponsor, Nationale-Nederlanden Life Insurance S.A., will be:

- 15,000 PLN for 1st place (highest fundraiser),
- 10,000 PLN for 2nd place,
- 5,000 PLN for 3rd place.

A symbolic award ceremony for the top fundraisers will take place on September 29, 2024, on the main stage of the 46th Nationale-Nederlanden Warsaw Marathon.
